 - Physical card order will be accepted through October

- Physical gift card orders will be delivered/pick up scheduled after 11/6/19
- **Von Hanson's:**
 - GBC will contact Von Hanson's 1/1/20 to reserve 2020 weekends in June and August (avoid last 2 weekends in July for Gypsy Village campers)
- **Butter Braids – T&T:**
